PARK RULES & DAMAGE POLICY

CONE GROVE PARK

PARK RULES

1. **NO overnight camping.**
2. **NO vehicles are allowed on the lawn unless a Gate Access form is completed for the BBQ area only. Failure to comply with the requirements of the Gate Access form could result in damage to County Property. You will be billed for any damage to the property.**
3. **NO glass containers are allowed.**
4. **NO persons other than a peace officer or a person licensed to carry concealed firearms pursuant to Penal Code Section 26150 et. seq. shall use, maintain, or possess any firearm or other dangerous or deadly weapon within the park boundary.**
5. **Park closes at 11:00 p.m.**
6. **NO burning of trash in the barbecue grills.**
7. **NO inflatable bounce houses, water slides, trampolines or similar equipment is allowed.**
8. **Trash must be placed in trash cans.**
9. **BBQ area sink must be cleaned after use.**
10. **Dogs are allowed only when on a leash.**
11. **NO loud music. If you or your guest(s) are unruly or if your music is so loud that it disturbs other Park patrons or the Caretaker, THE SHERIFF WILL BE CALLED.**

DAMAGES POLICY

The Caretaker will inspect the Park after your event and will notify the Parks Reservations Office of any violation(s) of the park rules or damages to park property.

1. The area you have reserved must be left clean. Please inspect your area to ensure all trash has been removed from the area or placed in trash cans.
2. The area you reserved must be left in good condition. The cost to repair any damage to your area (picnic tables, barbecues, etc.) will be billed to you. If the County is not paid in full for all damage to County property, you will be prohibited from reserving any park spaces in the future.
3. If the Sheriff's Office has been called out to the park because of loud music or unruly guest(s), You will be billed for any damages or costs incurred by the County.
