#### **ORDINANCE NO.** 1918

### AN ORDINANCE SETTING AND AMENDING CERTAIN FEES CHARGED BY THE TEHAMA COUNTY DEPARTMENT OF BUILDING AND SAFETY

THE BOARD OF SUPERVISORS OF THE COUNTY OF TEHAMA ORDAINS AS FOLLOWS:

**SECTION 1.** Effective commencing on July 12, 2009, the amounts set forth in the fee schedule entitled "Department of Building and Safety Fee Schedule," a copy of which is attached hereto as Attachment "A" and is made a part hereof as though fully set forth herein, are established as the fees for the designated services performed and permits issued by the Tehama County Department of Building and Safety. Upon that date, the fees set forth in this Section shall supersede those portions of any prior ordinance or resolution establishing any of the fees listed in Attachment "A."

SECTION 2. This Ordinance shall not affect any fee that is not listed in Attachment "A."

**SECTION 3.** The Board of Supervisors hereby finds that the fees set forth in Section 1 of this Ordinance are authorized by, and consistent with, California Constitution, article XI, section 7, Health & Safety Code section 17951, subdivision (a), Government Code section 66014, subdivision (a), California Code of Regulations, title 25, section 20, subdivision (a), California Building Code section 107.1, Tehama County Code, chapter 15.02, section 15.02.360, and the other statutes set forth in Attachment "A."

**SECTION 4.** The Board of Supervisors hereby finds that the fees set forth in Section 1 of this Ordinance are reasonably necessary to recover the costs of providing the services and issuing the permits described therein, and that the costs imposed by such fees are fairly apportioned so that charges allocated to any payor will bear a fair and reasonable relationship to the payor's burdens on or benefits from the services performed and permits issued by the Tehama County Department of Building and Safety.

SECTION 5. For the convenience of the public, Attachment "A" lists certain statutory fees that are charged by the State of California and must be collected by the Tehama County Department of Building and Safety on behalf of the State. The State of California may increase these fees, or establish new mandatory fees, which shall be effective and may be collected by the Tehama County Department of Building and Safety on behalf of the State, as required by law, without further action by the Board of Supervisors.

**SECTION 6.** This ordinance shall take effect sixty (60) days from the date of its adoption, and prior to the expiration of fifteen (15) days from the adoption thereof shall be published at least one time in the *Red Bluff Daily News*, a newspaper of general circulation in Tehama County.
